- 3. The shop should be located in Local Shopping Center, DDA, NDMC, commercial complex premises / notified commercial street or in Commercial premises or shops located in 2021 Master Plan and Commercially declared Road of Delhi.
- 4. In case of Community Shopping Centre shifting/opening of liquor shops are not allowed in Delhi as per Excise Rules / Act.
- 5. The premises should be of "A" class R.C.C. construction and should have independent electric meter and should have minimum 5KV load.
- 6. The acceptance of shop premises shall be subject to the approval of the site inspection committee constituted for the purpose by Excise Department, Govt. of NCT Delhi. The person whose premises which is finally accepted shall have to execute an agreement with the DTTDC for agreeing to give the said premises on Model rent agreement after commencement of smooth sales at the vend. The agreement registration is mandatory with respective authority. The registration charges will be shared mutually.

- 10. Mere submission of application for a liquor vend does not guarantee that liquor vend will become operational. The liquor vend will become operational only after the written permission is received from the Excise Department, Govt. of NCT Delhi.
- 11. Application without documentary proofs/ Affidavits/NOCs mentioned in the application form shall not be entertained.
- 12. The rent of the shop will accrue to the owner from the date the Shop become operational. (DTTDC will commence payment of rent in the first month of vend shifting from the date of commencement of sales and not from date of possession given by Shop Owner/Owners to DTTDC).
- 13. DTTDC will not be liable to pay any payment of rent compensation in case due to circumstances beyond the control of DTTDC such as political / public agitation / litigation or any other factor, the sale at the liquor vend is stopped or license of the Liquor vend is suspended/revoked by the Excise Department, Govt. of NCT Delhi.
- 14. The opening/running of the liquor vend will be as per the policy of Excise Department, Govt. of NCT of Delhi.
- 15. As per rule 51(1) of the Delhi Excise Rules, 2010, no retail vend of Indian Liquor, Foreign Liquor or Country Liquor shall be located within one hundred meters from the following, namely.-
- (a) major educational institutions;
- (b) religious places.;
- (c) hospitals with fifty beds and above:

Explanation 1- For the purpose of clause (a) above major educational institutions would mean middle and higher secondary schoots, colleges and other institutions of higher learning recognized by the Government.

Explanation 2 – For the purpose of clause (b) above, a religious place would imply a religious place having a pucca structure with a covered area of more than 400 square feet.

- **Explanation 3** ~ The measurement of distance shall be the shortest traversable distance. from the mid point of the actual main entrance/door of the premises proposed for license to mid point of the actual main door/entrance of the building of the places mentioned in clauses (a) (b) and (c) above.
- 16. Applications form in the prescribed proforma (Annexure- I) along with other relevant documents, for liquor licence shall be made to the Chief Manager (Liquor).
- 17. Applicant will submit the following documents along with the application:-
- (a) Proof of lawful possession of the proposed premises i.e. ownership/lease/rental documents etc.
- (b) An affidavit in the form given in Annexure- II declaring that :
- (i) He is in actual physical possession of the premises for which he has made an application for grant of liquor license.
- (ii) There is nothing adverse against the applicant as per the provisions of rule 23 of the Delhi Excise Rules, 2010.
- 18. A layout plan of the area in which the shop is located, clearly showing the proposed premises/vend.
- 19. Information, as required in the application form, shall be furnished with complete details and enclosures, truly and faithfully, so as to enable smooth processing of the application. The applicant shall not be entitled to any relief or compensation on account of delay in the finalization of his case *for* grant of the license.
- 20. The applicant, whose application is not complete in all respect, will be given 15 days time to remove the deficiencies failing which the application shall be rejected summarily without any further notice.
- 21. If, on scrutiny, any application is found incomplete, vague, confusing or not as per the terms and conditions, the same shall be summarily rejected and the decision of the licensing authority shall be final.
- 22. These terms & conditions, unless repugnant to the express provisions of the Delhi Excise Act, 2009, and the Rules made there under, shall be in addition to the said Act and the Rules, which are deemed to be incorporated in these terms & conditions as if they are expressly set out herein. Applicants are advised to access, read and understand the same before applying.
- 23. The Excise Department reserves the right to cancel or suspend any license at will as per provision section 17 of the Act.
